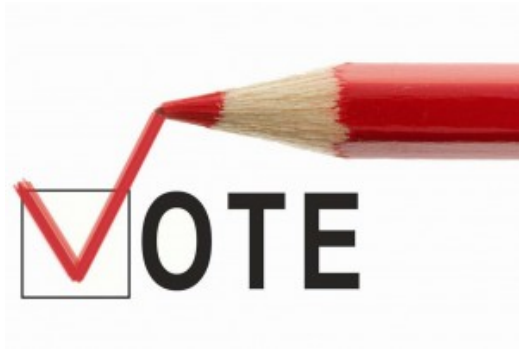

CMS has addressed carriers concerns about the lack of oversight regarding ACA applications they receive during SEP. In 2015 and prior CMS has relied on the honor system and therefore there has been little oversight of applicants claiming a qualifying event. CMS has eliminated six (obscure and rarely used) qualifying events, and will now require an applicant to provide documentation ...

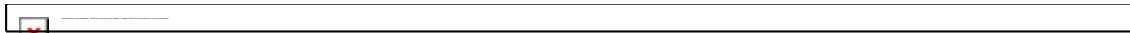
