### **NAHU's Response to AHCA Abandonment and the Future of Healthcare Reform**

The fate of healthcare reform remains in question a week after House Speaker Paul Ryan (R-WI), in consultation with President Donald Trump, decided to cancel a scheduled vote last Friday on the American Health Care Act (AHCA), the reconciliation bill to repeal and replace certain provisions of the Affordable Care Act (ACA). Following this decision, NAHU's Legislative Council Chairman Dave Mordo was interviewed this week on what this means moving forward and what can be done to stabilize the market for 2018. Meanwhile, congressional Republicans have sent mixed messages as to whether they would attempt to bring back legislation to repeal and replace the ACA...
