New Perspectives on Dentistry: Influence of Oral Health on General Health

"Who would have thought that getting your teeth cleaned could save your life?"

Dr. Barrett will reveal the advances that have been made in the dental industry over the past 25 years. Specifically, he will explain how a lot of diseases in the body can be discovered orally, often at a dental check up or cleaning. For example, The National Institute of Health has recently discovered that specific enzymes that are produced in the mouth during the advanced stages of periodontal (gum) disease contribute to the development of arterial heart disease. This is also true for expectant mothers who have periodontal diseasesscientists have now discovered that those enzymes the mother produces while pregnant result in the baby's birth defects and diseases. What does the future hold? Scientists are developing a "cavity vaccine" and the National Institute of Health will begin recommending additional dental check ups for expectant mothers.

Local Elections – Where The Rubber Meets the Road

If Senate Bill 51 wasn't a good enough example why TAHU and every TAHU member should be active in legislative and political arenas, there are numerous others — like that Dallas News story ("Group Starts Grass-roots Effort for Mandatory Health Coverage in Texas") a few days ago, Massachusetts' new "Pay or Play" law, and the "Walmart" bill in Maryland which is being introduced in other state legislatures.



We can make a difference. We did on SB 51; let's build on that experience in the upcoming election.

The governor's race has gotten all the headlines, but there's a lot we can do to secure our future in this business. We're not going to beg you only to vote, but to get active NOW in your local campaigns. A number of state House seats are up for grabs. YOU can make a difference in who wins them by contributing to, working for and supporting the right candidate. Believe me, you make that much of a difference; just ask the candidate.

TAHU, through its political action committee, has contributed more than \$30,000 to three dozen state senators, representatives and candidates in this election cycle, all aimed at keeping those who share our philosophies in office. While those contributions are important, nothing, absolutely nothing, will resonate with the candidates like YOU being personally involved, spending a little time doing some volunteer work at the campaign HQ, dropping by a personal contribution. It's not a sophisticated or slick process. Simply pick up the phone, call the campaign and ask, "How can I help?"

I am personally proud and honored to be part of the TAHU legislative team which works hard every day on the TAHU legislative program. TAHU needs you to step up and work your magic on the local level.

On the Federal Scene

We received news of the Congressionally-mandated "Citizen's Health Care Working Group" and its recommendations for a national " 'public or private program' to ensure universal participation of all Americans in a uniform plan that will provide a very broad range of covered services with additional protection for catastrophic expenses regardless of financial resources or health status." E. Neil Trautwein with the National Retailers Federation says it best: "... despite the admirable ambitions and lofty rhetoric, the fundamental premise of the Citizen's Health Care Working Group is flawed. Everyone can't have everything in health care without breaking the collective bank. Given that there is no right to universal health care enshrined in the Constitution or its shadow, wouldn't our time be better spent addressing the true cost-drivers in health care and curing the myriad dysfunctions that complicate health care and increase its cost? Wouldn't that be a system worth aiding access to at a more affordable cost?"

TDI Update

There's been a ton of discussion about the Commissioner's Bulletin B-0028-06 "Individual Employer Health Plan Coverage". Some have said the Bulletin went too far and actually established new rules. Got SB 51 News?

Just a reminder that TAHU is in a great position to make recommendations for any legislative changes in this new law but we will have to have accurate, credible information to present to the Legislature first. 
Hello everyone!!
