TDI News

Order re: NCCI filing Item 01-TX-2016 (Elimination of A-Rating Process)

TDI has posted an order approving a filing by the National Council on Compensation Insurance (NCCI) to eliminate the A-rating process for certain national and state special classification and statistical codes in Texas, with a change to keep classification code 0923 A-rated until July 1, 2019. The other changes in Item 01-TX-2016 apply to new and renewal policies with effective dates on and after July 1, 2017.
